COMMUNICATING WITH NEIGHBOURS AND THE LOCAL COMMUNITY

The location of Mainfreight is outlined in **Section 1.1** of the EPA License and can be seen in the figures within that section. The warehouse is located within an industrial area with no residential neighbours.

In the event of a pollution incident, Mainfreight has established the following processes for contacting the local community:

- If an incident occurs, site management will immediately notify the five regulatory authorities that are listed in **Section 5.5**.
- Mainfreight will deliberate with the regulatory authorities to determine if the community is to be notified of the pollution. The same management team will discuss the most appropriate communication channel with the regulatory authorities. This could be in the form of the following: media release, radio announcement, social media release.
- The risk level of the incident will play a large role in determining the notification channel that Mainfreight uses if it must notify neighbours and the community. Some of these strategies will include the following: door knocking, letter drop, phone calls, text messages, email.
